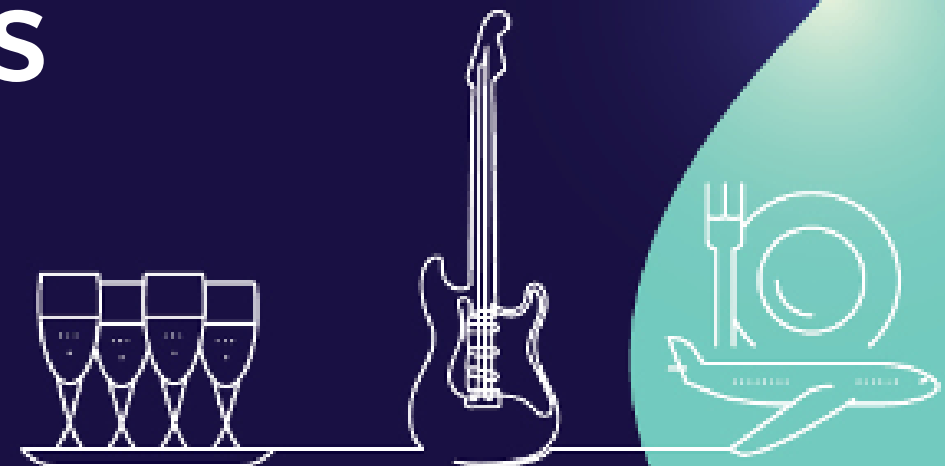

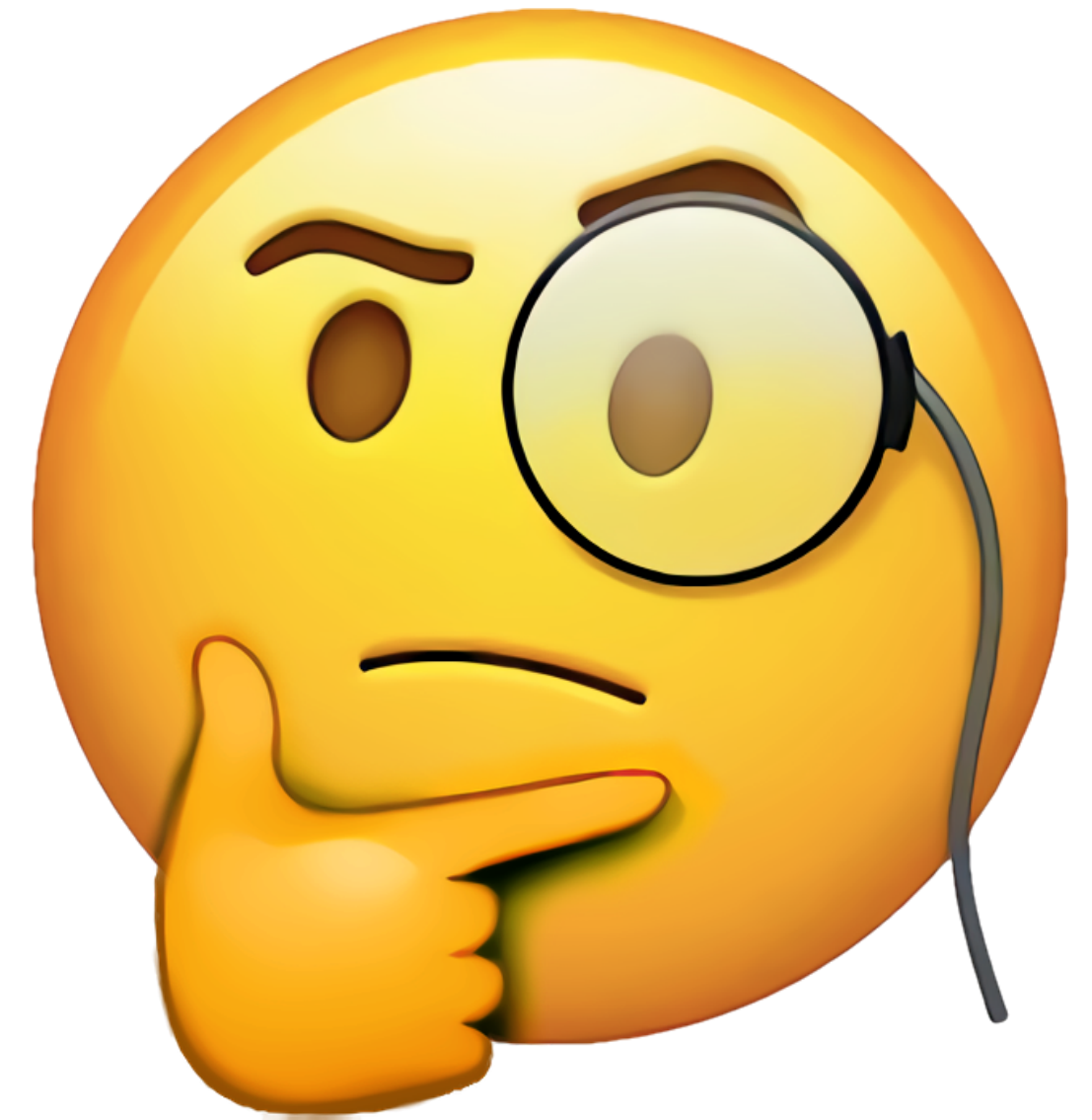

Virginia Cervantes said her daughter got engaged in March 2021 to a man named Kevin, and they had their wedding date planned for this month.







**What the heck

"indemnity"
mean?**

- 
- A contractual obligation
 - Of one party (the indemnitor)
 - To compensate the other party (the indemnitee)
 - For the losses incurred by the indemnitee
 - As a result of the acts of the indemnitor or a third party

Client Service Agreements: The Missteps

■ Force majeure, rescheduling, and cancellations

■ Termination WITHOUT cause

■ No default provision

■ Undefined planning services
